**TRANSFER ARRANGEMENTS  
PRIMARY TO SECONDARY EDUCATION 2022/2023**

Dear Parent/Carer

Your child is due to transfer from primary to secondary education at the beginning of the new school session in August 2022.

Further to the implementation of the Council's consultation on School Admissions and Transfer Arrangements from primary to secondary in August 2020, parents residing within the area of East Dunbartonshire are required to complete an online application to register for S1 at their preferred catchment secondary school. You will be required to provide evidence of residency within the delineated catchment area of the secondary school during the online application. The evidence should include: Council Tax bill, a recent utility bill within 3 months, Child Benefit Statement or bank statement showing Child Benefit is paid to you.

The online registration form will be available on our website week commencing 13 December 2021. All applications are required to be submitted by Friday 14 January 2022. I have attached the link to our webpages where you can find the relevant information and the registration form:

Please note: If your child attends the current primary school by means of a placing request, you must register your child at your catchment secondary school. You must do this prior to submitting a placing request. This will ensure that there is a place for your child in the event that your placing request is not accepted.



### **Placing Requests**

Under Section 28A of the Education (Scotland) Act 1980, you are entitled to make a placing request for your child to be placed in another school. The council has a duty to comply with that request except in certain circumstances as detailed on the guidelines.

The closing date for School Placing Requests is **15 March 2022**. Any applications received after this date will be considered as a late application. Should your request be successful you will be required to meet all transport costs other than in exceptional circumstances.

Details of transition arrangements, including dates and times of parents meeting and inductions, will be issued in due course.
